A Message From Your V.P. Membership

The Conejo Ski and Sports Club Continues to Attract Active Adults

Ski outings, weekend camping trips, hiking as well as themed parties (our Mardi Gras party is coming up), socializing and gathering to just have fun continues to attract new members to our club. Our diverse and active calendar of events in 2013 attracted nearly 80 new members to

the CSSC during the year - - making it another successful and fun year. As we enter 2014 CSSC boasts an active membership of just over 400 like-minded active adults.

During 2013 one in five of our active membership roster was a new member. Generally new members come through the year, but two months dominated. May and September saw the most new members join our merry group.

SPRINGTIME FOR SKIERS IN JANUARY! by Carol Tubelis

45 trusting Conejo members boarded the bus in Newbury Park for Mammoth on Thursday, January 23rd, to go skiing when there had been very little snow in the mountains so far this year. Mark Glasmier promised it would be OK, and it was. The number of chairs operating was limited, but those runs that were open served us well, and we had great spring skiing. Mammoth Mountain has all the latest in snow making equipment to provide snow magic!



The ride on the big bus up and back passed quickly as we were treated to recent movie releases, like Gravity and Captain Phillips, and to vintage ski videos. Snacks and drinks were abundant, and warm personal pizza and yummy cookies on the return trip kept us content. The condos at Snow Flower were very comfortable this trip; no more than six assigned to each unit offering plenty of room to spread out. We were scheduled to go to Whiskey Creek for an early dinner on Friday, but surprise! ... this favorite establishment closed its doors on Thursday. Not to worry, quick change artist, Mark, got us into Gomez's Mexican Restaurant and Cantina for an excellent Happy Hour, and then home on the bus for a nice, soothing jacuzzi. Saturday, after skiing and before dinner, there was a formidable volleyball game played out on the condo commons. that night's dinner was a catered affair and a 75th birthday celebration for one of our youngest members; champagne and yummy cake for everyone! Next day we skied until around 2 PM, and then home to Newbury Park before 9 PM Sunday night.

The first Mammoth trip of the year was great fun all around. You need to remember, Mammoth is not just for skiers. It's for hikers, bikers, shoppers, loungers and lovers. You should try it, you'd like it!

STAYIN' ALIVE by Julianne Seeley

In January the club arranged the first ever hands-only CPR training, conducted by American Medical Response of Ventura County. Over 50 club members attended this free training, and learned how to perform this form of CPR, to one day, potentially save a life.

When a person's heart stops, they are clinically dead. The first 3-4 minutes are the most important. After 4 minutes, without blood circulating to the brain, brain damage sets in. Nationally, approximately only 22% of those who who suffer cardiac arrest survive. The number is so low due to the time it takes to get emergency personnel to the scene (approximately 6-7 minutes nationally). Hands-only or sidewalk CPR means no mouth-to-mouth breathing. Instead it involves steady chest compressions. By circulating blood to the brain and organs, this method can buy lifesaving minutes after a person's heart stops beating, until emergency personnel arrive. With the application of hands-only CPR prior to emergency personnel arriving, the survival rate goes up significantly.

The training was such a success that the club is looking to have sessions taught on an annual basis.



You can also add \$50 to the Tahoe Package if you want to pre-pay for a 6th day of skiing at Heavenly, Kirkwood or Northstar Mountain. Round Trip Shuttle Transfers to Kirkwood Mountain are not included in the Tahoe Package.





Solstice Canyon Hike



Saturday, March 22

Solstice Canyon is a place were you can experience nature. Native Chumash Settlers first used the canyon for food, water and shelter. Henry Keller built a stone house in 1903. The trail leads to the Roberts house, designed in 1952 by renowned African American architect Paul Williams, was destroyed by a fire. An arched stone courtyard garden terrace and exotic tropical plants still remain. Near the ruins, a waterfall, cascades 30 feet over sandstone rocks. The trail meanders through a lush canyon with a sweeping vista. The hike is 4 miles roundtrip with an elevation gain of 1,000 feet.

CONDUCT POLICY OF THE CONEJO SKI & SPORTS CLUB



Conejo Ski & Sports Club (CSSC) sponsors various activities for a varied population.
