




DRIVE UP DAY EARLY THURSDAY Drive up day before -Aug.16th to book room at Tom's Place or nearby hotel in Bishop for an early start to pack station next morning 7AM August 17. Hotel accommodations at Tom's Place must be made by phone: Call (760) 935-4239. Tom's Place has a special Prime Rib Dinner for only \$11.50. Check out their café menu at <u>http://www.tomsplaceresort.com</u> Limited to 20 horseback riders.

THE FOLLOWING IS PROVIDED: Horses, saddles, food, kitchen utensils, & camping equipment. Private tents for singles, couples, or families provided upon request. Food will be plentiful and **deluxe** in quality. Preparation of food is provided however, help is always appreciated. Those that want to learn to pack and make up loads may participate in packing the mules.

**Riders:** Day one we ride from the pack station to Dorothy Lake which takes about two hours. Following, lunch and leisure time, we ride to a camp on the East Fork of Rock Creek which is about another 45 minutes. Riders cost \$575. Riders Will be camped on the East Fork of Rock Creek. There are nearby ponds and lake. **Hikers:** want to join the trip they can get to the campsite in less than an hour. Or, they can go for a day hike and spend as much time as they want getting to camp. The trail for hikers will depend on how many, and the qualifications of the hikers. Generally, we have hikers depart from the Tamarack trailhead on the Westside of Rock Creek Lake. Cost \$300. They can bring wine and beer. I will give your group one mule to pack in wine, beer and ice. The area we are camping and traveling through is called *The Tamarack Basin*. There are numerous trails alongside of creeks and meadows. We travel to *Francis, Dorothy, Catherine, Dam* and *Round Lakes*. And, there are numerous ponds in this area. The last day we will return in early afternoon. Generally come back around 3 in the afternoon.

They have 4 queen size rooms at \$ 65 a night. 1 room with two twins at \$ 85 a night. Men's dorm room with 6 beds at 30 a night. Women's dorm room 5 beds at 30 a night. ### CONDUCT POLICY OF THE CONEJO SKI & SPORTS CLUB



Conejo Ski & Sports Club (CSSC) sponsors various activities for a varied population. The CSSC Conduct policy was developed to maximize the enjoyment for all participants and to provide guidelines for CSSC. This policy applies to all persons participating in a CSSC activity. All participants are requested to observe common courtesy and generally accepted standards of behavior. Activities include, but are not limited to CSSC sponsored trips, parties, sports and cultural activities. CSSC will not tolerate violation of any Federal, State or Local laws or ordinances.
