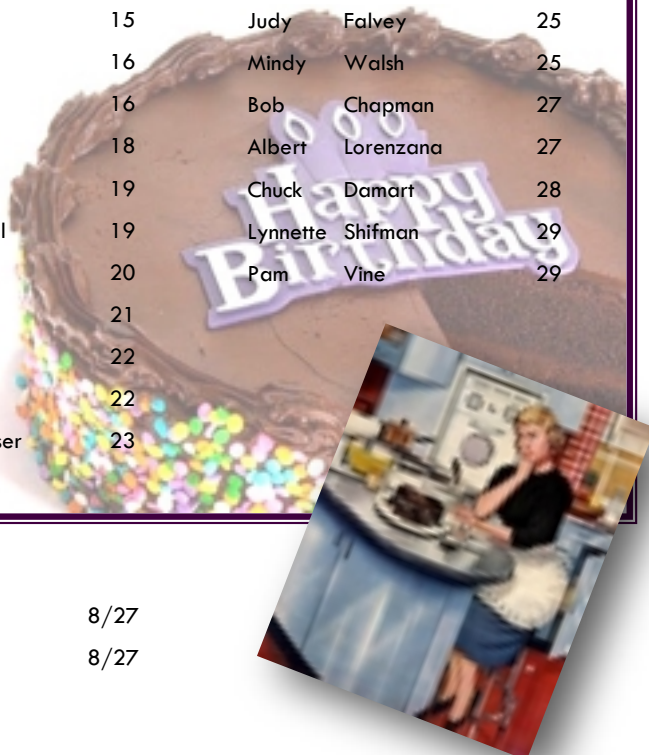

WAIVER

SPORT PARTICIPANT RELEASE OF LIABILITY, WAIVER OF CLAIMS, EXPRESS ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

Please read and be certain you understand the implications of signing.

Express Assumption of Risk Associated with Sport, Venue Use and Related Activities. I, *(Your name)* \_\_\_\_\_

do hereby affirm and acknowledge that I have been fully informed of the inherent hazards and risks associated with

*(Activity name)* \_\_\_\_\_ activities, transportation of equipment related to the activities, and traveling to and from activity sites in which I am about to engage. Inherent hazards and risks include but are not limited to:

1. Risk of injury from the activity and equipment utilized is significant including the potential for broken bones, severe injuries to the head, neck, and back or other bodily injuries that my result in permanent disability and death.
2. Possible equipment failure and/or malfunction or misuse of my own or others' equipment.
3. I AGREE THAT I WILL WEAR APPROVED PROTECTIVE GEAR AS DECREED BY THE GOVERNING BODY OF THE SPORT I AM PARTICIPATING IN. However, protective gear cannot guarantee the participant's safety. I further agree that no helmet can protect the wearer against all potential head injuries or prevent injury to the wearer's face, neck or spinal cord.
4. Variation and/or steepness of terrain, variation or changes in surfaces including but not limited to snow surfaces, ice, bare spots, rocks, stumps, debris, cliffs, trees, fences, posts, trees, light poles, signs, buildings, roads, walkways, ramps, rails, stairs, pyramids, manual pads, bowls, half-pipes, jumps, padded and nonpadded barriers, other persons, and other natural and man-made hazards.
5. My own negligence and/or the negligence of others, including but not limited to operator error and guide decision making including misjudging terrain, weather, riding surfaces or other obstacles.
6. Exposure to the elements and temperature extremes may result if frost nip, frost bite, heat exhaustion, heat stroke, sunburn, hypothermia and dehydration.
7. Dangers associated with exposure to natural elements include but are not limited to avalanche, rock fall, inclement weather, thunder and lightning, severe and or varied wind, temperature and other weather conditions.
8. Accidents or illness occurring in remote places where there are no available medical facilities.
9. Fatigue, exhaustion, chill, and/or dizziness, which may diminish my/our reaction time and increase the risk of accident.
10. Impact or collision with other athletes, spectators, facility employees, pedestrians, motor vehicles, and cyclists.

\*I understand the description of these risks is not complete and unknown or unanticipated risks may result in injury, illness, or death.

**Release of Liability, Waiver of Claims and Indemnity Agreement**

## **Conejo Ski & Sports Club Cancellation Policy**

Since its time to sign up for ski and travel trips, we think this is a good time to review the Conejo Ski & Sports Club (CSSC) Cancellation policy.

Section 7.1 of the CSSC Board Manual states, generally, that there are no refunds of travel deposits or payments without replacement. This policy applies to travel trips, ski trips, Mammoth trips, activities, and social events.

As a club member, you enjoy substantial financial benefits derived from group travel bookings. In addition, CSSC is a California Seller of Travel which means that CSSC can choose not to use a travel agent to book airfare, coaches, accommodations, tours, etc. When CSSC acts as your travel agent and books its own ski or travel trips, it can save members between 10 and 15% by cutting out the middle-man travel agent.

The major costs of a ski or travel trip are the accommodations, the air, ski passes, and coaches. We book accommodations, double occupancy, quad occupancy, or in the case of Mammoth, 7 persons per condo. Your member price is based on the cost of the "unit" divided by the number of people in the unit. If the price of a unit is \$1,000, then the cost per person double occupancy is \$500, quad occupancy is \$250, and for 7 person per unit - \$142.85. Instead of paying the full \$1,000, CSSC members receive the benefit of large group pricing.

What happens when we have a cancellation? If we have a waiting list, the member on the waiting list writes a check to the cancelling member for the amount of money he or she has already paid and then pays the balance due to the trip provider. This is called "refund with replacement" and is the best result for CSSC members.

**When there is no one to take the cancelling member's place it can have serious financial consequences on the trip and for the members who do not cancel.** Instead of having two in a hotel room paying \$500 each, we now have only one in the room which still costs \$1,000. If we have a couple cancel in a quad condo, the price increases from \$250 each to \$500 each, and so on. By his or her cancellation without a replacement, the cancelling member has increased the non-cancelling member's cost of the trip by a substantial amount. Someone has to come up with the money to cover this extra cost.

**This is why we have the no refund without replacement policy and why you may see non-refundable deposits that are equal to the single supplement, the airline cancellation fees, and other costs on a travel trip.** (Ski trips - all payments are non-refundable, Belize was \$800)

If your money is paid to CSSC and put in the CSSC travel trust account, CSSC will use the non-refundable portion of the cancelling member's payments to pay for the cancelling member's portion of accommodations, air, ski passes, and coach. This ensures the trip does not lose money and that the member who is NOT cancelling does not end up paying for the single supplement. These CSSC cancellation procedures only apply when checks are made payable to CSSC and go into the CSSC travel trust account.

If you write your check to a third party travel agent, the contract is between you and the third party travel agent. Since CSSC is not involved in this transaction, you will need to either contact your trip leader for an explanation of the third party travel agent cancellation policy or the third party travel agent you write your check to and find out who pays the single supplement should your roommate cancel their trip. In the past, the non-cancelling roommate has ended up paying the single supplement to cover the remaining cost.

Due to these various cancellation policies, CSSC strongly recommends you purchase travel insurance that includes coverage for trip cancellation, medical, and medical evacuation. A website where you can review over a hundred different trip cancellation and travel insurance policies is [squaremouth.com](http://squaremouth.com).

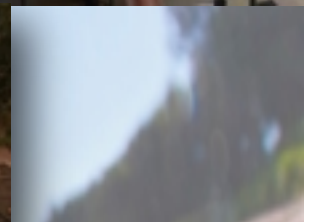

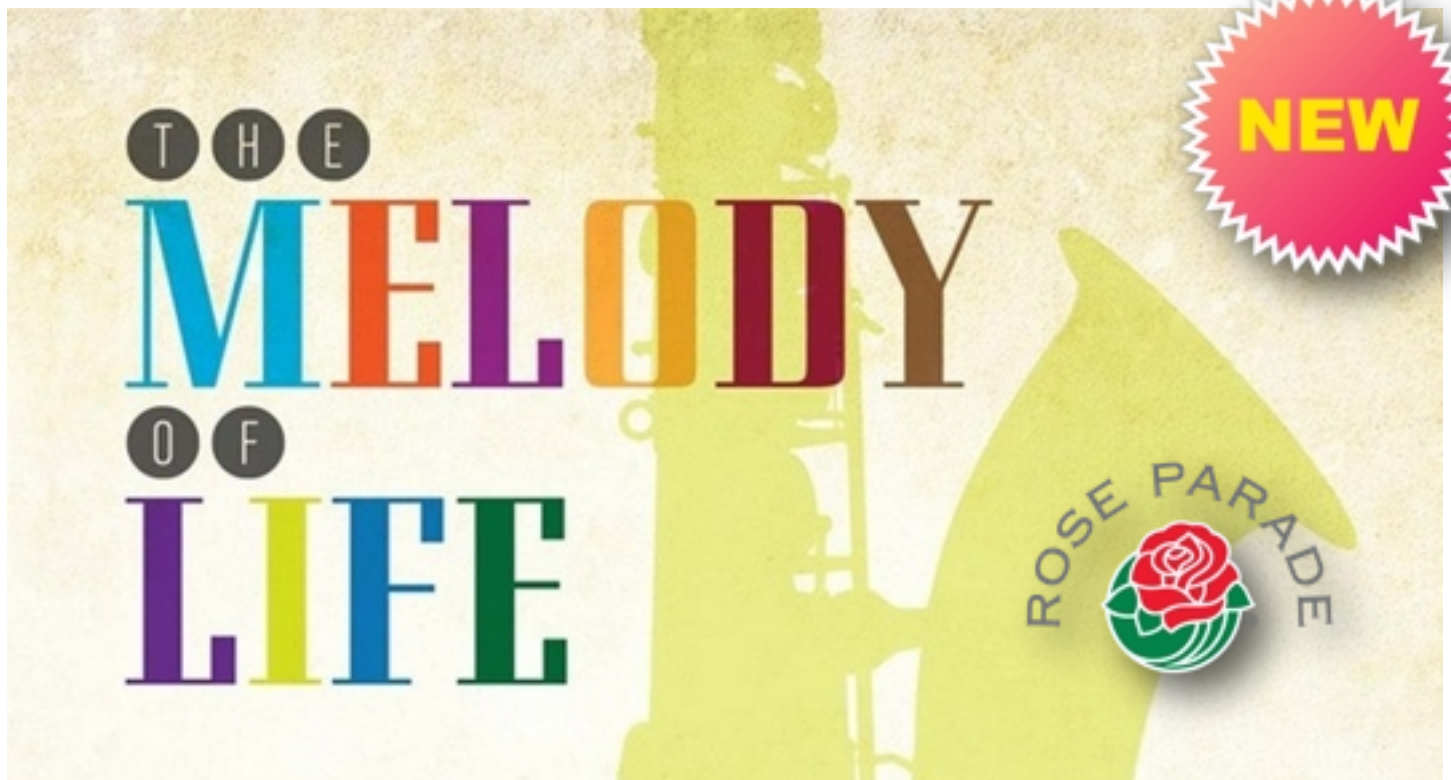

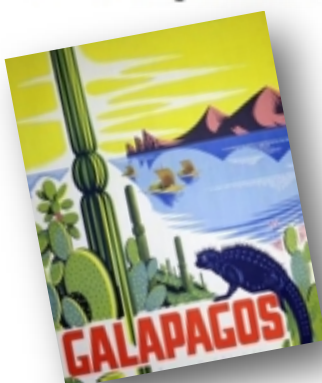

**May 11 (Sat): Depart USA/Arrive Peru.** Your exciting expedition begins today as you depart LAX at 1:30 PM. After a short layover you'll arrive in Lima where you'll be met by your guide at the airport and escorted to your upscale hotel. **Jose Antonio Bellavista Hotel**

**May 12 (Sun): Lima.** Explore Lima, known as the City of Kings and the center of the Spanish Empire in the New World for three centuries after Pizarro's conquest. Enjoy a guided afternoon tour of both colonial and modern Lima, founded in 1535 and later dominated by the Inca nation. See the historical center and the San Francisco Church as well as Plaza de Armas and the Government Palace. Each of these islands has its own unique beauty to offer. North Seymour is a flat Island and home to magnificent frigate birds like the Blue-Footed-Boobies. South Plazas Island is home to a large colony of sea lions and offers excellent examples of the typical flora like towering cacti "trees" which form the principal diet for land iguanas and cactus finch. Bartholomew Island is a tiny island which boasts one of the most spectacular views of the Archipelago from Pinnacle Rock. Climb to the peak at 114 meters to enjoy this stunning view.
