



WAIVER AND RELEASE OF LIABILITY AND CONDUCT POLICY
(READ BEFORE SIGNING)

In consideration of being allowed to participate, in any way, in the Conejo Ski & Sports Club programs, related events, and activities I, _____ (Participant's Name Printed) the Undersigned, acknowledge, appreciate, and agree that:

1. The risk of injury from many of the activities is significant, including the potential for permanent paralysis and death, and while particular skills, rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

2. **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES** or others and assume full responsibility for my participation; and,

3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,

4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS** Conejo Ski & Sports Club, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the event ("**RELEASEES**"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**, to the fullest extent permitted by law.

Activity participant agrees that this release will apply to all known and unknown as well as unanticipated claims, injuries and damages resulting from club activities, as well as, those now disclosed and all rights under section 1542 of the Civil Code of California are hereby expressly waived. Section 1542 of the Civil Code of California reads as follows:

"A general release does not extend to claims which the (person signing the release) does not know or suspect to exist in his (or her) favor, at the time of execution of the release, which if known by him (or her) must have materially affected his (or her) signing the release."

In addition, I have read, understand and agree to the Conejo Ski & Sports Club (CSSC) Conduct Policy which states: *"All participants are required to observe common courtesy and generally accepted standards of behavior. CSSC will not tolerate violation of any federal, state, or local laws or ordinances. Illegal use of drug, tobacco or alcohol will cause the participant to be removed from the event. Additionally, CSSC will not reimburse the participant for any forfeited payments. CSSC may also choose, for the benefit of all participants, to prohibit smoking or alcohol at events. Participants who display obnoxious or offensive behavior in violation of this conduct policy, as determined by the CSSC event representative, may be removed and/or isolated from the group. Participants shall adhere to the requirements of the CSSC event packages (i.e. lift tickets) and not transfer, resell or barter all or portions of the package. Additionally, if behavior offensive to others (profanity, off-color humor) continues after the offending person is asked by a CSSC representative to refrain from its use, the offending participant may be subject to sanctions up to removal from the activity and/or removal from the club."

CANADA/NEW ENGLAND STATES FALL FOLIAGE CRUISE

OCTOBER 5-14, 2022 CSSC CST # 2109794 & Vacations-to-Go CST # 2043190

We will arrive in Quebec City mid-morning on October 6th and head off for a special Ile d'Orleans Tour (possibly with wine tastings at a vineyard or two) for the afternoon. We then check into our 4-star hotel, the Courtyard by Marriott in Quebec City (it has a Starbucks located inside for those diehard coffee lovers). Welcome Dinner at the hotel with wine is included. All rooms include 2 queen beds. The next morning after breakfast, we check out and head off to our pre-selected bike or city walking tour. One bike tour is a flat 16 miles, and goes to the famous **Montmorency Falls**, with stops at points of interest along the way. When we arrive at the bottom of the falls, we'll take a cable car to the top of the cliff, for a breathtaking view of the falls. We will walk over to a suspended bridge where there is a panoramic view of the Saint Lawrence Seaway. The other bike tour is the Lower Town tour, and is a flat 8 miles of fabulous site seeing in the historical district and heritage sites, exploring some of the more revitalized neighborhoods and plunging into the heart of the French Quebecois culture, with a stop at a Farmers Market with local products and tastings (we must have a minimum of 6 guests for this tour). There is an option for an "E" bike for an additional fee of approximately \$20. For those that feel they just can't do any biking, you will be included in a walking tour of the historical city (we must have a minimum of 4 guests for this tour). After our tours we will be picked up by our private coach and taken to the port to board our cruise ship, the **Norwegian Pearl** and sail for the next 7 days. Our cruise ship will stop at the following places:

Charlottetown, Prince Edward Island; Sydney, Nova Scotia; Halifax, Nova Scotia; Bar Harbor, Maine and Portland, Maine. We disembark the ship in Boston, MA.

Built in 2007, The **Norwegian Pearl** is one of the smaller ships in the Norwegian fleet. The ship's atrium is one of the most happening spots, functioning primarily as a place to commune. Nightlife is vibrant with Bar City (a stretch of four bars along a single corridor). The ship has more than a dozen dining venues, accommodating all tastes. The ship has an attractive casino with video games and slot machines, including penny slots, and crap tables offering Las Vegas style betting odds.

We will also plan some club exclusive events on the ship, such as our own private cocktail party and some club exclusive optional land excursions in each port.




